

CAC Scholarship Program - Fiscal Year 2017 Application
Valid for classes beginning July 1st 2016 – June 30th 2017

Thanks to Arundel Community Development Services (ACDS), Chesapeake Arts Center is able to offer tuition assistance to Anne Arundel County residents who live in Northern Anne Arundel County; especially Brooklyn Park, Glen Burnie, Severn, and surrounding communities of Northern AA County. Specific eligibility is defined by communities identified as priority revitalization areas.

To determine whether your family is eligible for scholarship assistance, add up your total household income. Check the box that corresponds with the number of people in your household and your total income. If you check a box in the fourth column, you do not qualify for this scholarship program. If you do qualify, the program pays from anywhere between 25-75% of the tuition based on which column your income falls under. The approval process is done on site at CAC after the application and proof of income is received.

CAC Attendance Policy: scholarship recipients who miss 25% or more of their scheduled classes may not be eligible for future tuition assistance.

Tuition assistance runs for a full fiscal year, beginning July 1 of each year. Thus, what you provide to us now will be valid thru June 30, 2017.

Please be sure to include proof of income when you return your application to CAC. The best document to send is the first page of your most recent Federal Tax Return. Otherwise, you can include two consecutive paystubs. If you receive any type of assistance, be sure to include the letter from the issuing agency which indicates how much you receive and how often.
